This is an update on the MHM Christmas Party for the Wounded, Wreaths Across America event and the Detachment Christmas party:

1. MHM Christmas Party

Thursday, 12Dec13: The Detachment Marines Helping Marines Christmas Party for the Wounded and their families at the Warrior Family Support Center (WFSC), BAMC/SAMMC will start at 5:00 pm. If you desire to help serve and/or help Santa please arrive between 4:30 and 5:00. Uniform is red Detachment shirt and cover.

2. Wreaths across America:

Friday, 13Dec13: If you want to help unload the wreaths from the trailers, please arrive at the Ft Sam Houston Cemetery Maintenance Shop (cemetery rear area) at 0900. This involves carry cardboard boxes off the trucks so wear something appropriate (clothing may get soiled).
